TROUBLESHOOTING

Scanner not working

- No power to scanner**
Check system power; ensure power supply, if required, is connected
- Incorrect interface cable used**
Ensure that correct interface cable is used
- Interface/power cables are loose**
Ensure all cable connections are secure

Scanner not decoding bar code

- Scanner not programmed for bar code type**
Ensure scanner is programmed to read type of bar code being scanned
- Bar code unreadable**
Ensure bar code is not defaced; try scanning test bar code of same bar code type; ensure bar code is not defaced; try scanning test bar code of same bar code type
- Distance between scanner and bar code incorrect**
Move scanner closer to or further from bar code

Scanner decoding bar code, but data not transmitting to host

- Scanner not programmed for correct host interface**
Scan appropriate host parameter bar codes
- Interface cable is loose**
Ensure all cable connections are secure

Scanned data incorrectly displayed on host

- Scanner not programmed for correct host interface**
Scan appropriate host parameter bar codes
